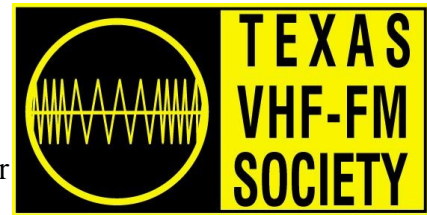


Texas VHF-FM Society General Meeting (Winter)
